

Frequently Asked Questions  
Regarding Camps Leelanau & Kohahna Summer 2020

***Day Camp***

- Day Camp? Really? What does that even mean?
  - Great question. It means you drop off your kid every day by **8:30 am**, we raise the Flag, feed them Breakfast, Study the Lesson, and launch into activities similar to a normal Camp Day, and you pick them up from the Big Tree **at 8:30pm**.
- I don't live nearby, how am I supposed to do this?
  - We realize that Day Camp may not work for everyone. If you have or plan to have a place in the area, or family with a place, or know someone with a place that is willing to host your child, we want to be here to serve your kid(s) and allow for a meaningful summer experience in-line with State requirements. Sorry, no daily helicopter deliveries.
- For Day Camp what should they wear? Bring? Can they keep some stuff at Camp?
  - More details will be sent to families that enroll in this program, but in general they should wear athletic clothes they are comfortable getting dirty and closed toe shoes. They should bring and plan to store at Camp a swimming suit, towel, layer, rain coat, lesson books, and a stuffed animal for rest hour.
- Can I do this ala carte? Some days in the week's session we come to Camp, some days we do other stuff?
  - No. This is all in.
- This sounds amazing. Thank you for this opportunity. I live in the area and can host a few more kids if that is helpful, how do I get in contact with other families from further afield?
  - Wow. We are humbled by your offer. We can help facilitate some initial contacts, but from there families need to work out their own details for taking care of each other's kids at night.
- Will you still be offering all of the same activities at Day Camp as you do for Residential Camp?
  - Our full staff of counselors will have already been at camp preparing for, and anxiously awaiting your children. This means we will be offering the same quality programming, and activities as this year's residential camp. Obviously the Trips Program won't get very far afield during Day Camp.

***General questions***

- You said the residential camp is still unknown. What happens if that date changes?
  - We will continue to be in touch as we hear from the State of Michigan and gain further certainty.
- Can I switch sessions if I was originally signed up for the Regular Three-Week Session but don't live nearby?
  - Yes, we will work with you to come up with a solution that works from the presented options.
- If I switch sessions will my Campership Award still apply?

- The CampershipFund.org is very committed to support each family and recognizes that change is inevitable this year. In addition, the L&K Campership Fund is very much committed to working with each family to make sure Camp is accessible.
- Will an Eagle's Nest staff still be at camp?
  - Yes, our Christian Science Practitioner and Christian Science Nurse will be on site all summer and available to support the Campers.
- What about CT's
  - CT's will arrive as usual on June 19. Getting them trained and having them as part of our team is an important element of our program.

***COVID-19 Policies, Plans, and Practices for both Day and Residential Campers***

- What is Camp's big picture thought on all of this Pandemic Business?
  - We are all practitioners first. We are all praying daily for ourselves, the world, our communities, our Camp Families, and for the idea of Camp. Prayer and our confidence and certainty in the effectiveness of Christian Science healing is our first and foremost layer of armor every day. However, we are also law abiding. We "render unto Caesar" and want to comfort our greater Leelanau County community and be good neighbors.
- Will there be COVID-19 screening?
  - Yes. In order to open, the State requires that prior to camper arrival we ask each parent to be alert to any health challenges including the CDC recognized symptoms of COVID-19, and if there has been any contact with anyone with a confirmed case of COVID-19.
  - Additionally, for Day Camp, those same questions will be asked each morning at drop off. For Resident Camp those same questions will be asked on arrival day, and then in a diminishing frequency throughout the session.
- What other measures will you be taking?
  - The State of Michigan Camp Licensing Guidance has asked us to also consider the following:
    - Camp in smaller groups, or cohorts. This means that a Cabin Group or two while already living together, and doing Quiet Time and Breakfast together, will do most of their activities and additional meals together too.
    - When multiple cohorts are in the same area, like the Greathouse for meals, encourage and expect physical distance to be maintained between cohorts.
    - Additionally, personal hygiene (specifically handwashing) should be encouraged and ramped up. (Something that every Leelanau boy needs to improve on anyway. 😊)
    - Our housekeeping staff and counselors are all trained to increase the daily cleaning and sanitizing of areas and spaces around Camp.
- Will my Camper need a mask at Camp?
  - Masks for Campers will be utilized infrequently, if at all. Counselors may be required to wear masks in certain circumstances.

- You mentioned Multi Session Discounts. Tell me more?
  - Great question. If you are going to attend both the One Week residential and the Four Week Session, thus being a "Five-Weeker" your session price will be \$4,525. If you are going to attend all seven weeks of Camp, your session price will be \$5,475.
